Roche-Novartis (Avastin) case report – update

The much-awaited judgment of the European Court of Justice (ECJ) on the *Roche-Novartis* (*Avastin*) case (C-179/16) has been delivered on 23 January 2018 upon request of the Italian Consiglio di Stato (Italy's supreme administrative court).

According to the ECJ the agreement between the pharmaceutical groups Roche and Novartis designed to reduce the use of Avastin in ophthalmology and to increase the use of Lucentis might constitute a restriction of competition "by object".

SLAC served as the advisor of the consumer organization Altroconsumo throughout the Italian proceedings as well as before the ECJ.

Lorenzo Schiano di Pepe appointed to the board of the Italian Agency for Flight Safety

On 22 December 2017 Lorenzo Schiano di Pepe has been appointed, by Decree of the Italian Prime Minister Paolo Gentiloni following a proposal of the Italian Minister of Justice, to the board ("collegio") of the Italian Agency for Flight Safety (<u>Agenzia Nazionale per la Sicurezza del Volo - ANSV</u>). The relevant press release of the Italian Government (in Italian) can be found <u>here</u>. The appointment is for a five years term.

ANSV is the investigative authority for aviation safety of the Republic of Italy, established pursuant to European Community Directive 94/56/EC later replaced by <u>Regulation (EU) No. 996/2010</u> of the European Parliament and of the Council of 20 October 2010.

ANSV is entrusted with the task of carrying out, for preventative purposes, safety investigations whenever an accident or incident in civil aviation occurs. In that vein, if necessary, safety recommendations are issued by ANSV. Besides, activities of study are also performed in order to enhance flight safety.

DUNNINGTON, BARTHOLOW & MILLER – United States



Egon Schiele Woman Hiding Her Face (1912)

On April 6, 2018, Raymond J. Dowd and Samuel A. Blaustein, partners at Dunnington, Bartholow and Miller LLP, won an important victory for Holocaust victims and their heirs against a London art dealer. Following a court-ordered seizure of the works at a Park Avenue Armory show, the heirs obtained a summary judgment ruling that two valuable artworks by the artist Egon Schiele are the property of the the heirs of an Austrian Jewish entertainer who was forced to sign a power of attorney in the Dachau Concentration Camp. Reif v. Nagy, 2018 WL 1638805 (N.Y. Sup.). Schiele's "Woman in a Black Pinafore" (1911) and "Woman Hiding her Face" (1912) were part of a 449-piece art collection in the Viennese apartment of Fritz Grünbaum when Grünbaum was arrested by the Gestapo following Anschluss. Grünbaum, a popular cabaret, film and radio performer was an outspoken critic of Hitler. This victory brings the heirs one step closer to recovering this important collection.

The court wrote, "A signature at gunpoint cannot lead to a valid conveyance." This ruling is one of the first successful applications of the Holocaust Expropriated Art Recovery Act of 2016 which extended the the statute of limitations for claims to recover artwork stolen during World War II to six years from the date of "actual discovery" of the "identity and location of the artwork." In rejecting a London art dealer's arguments the Court wrote: "Although defendants argue that the HEAR Act is inapplicable, this argument is absurd, as the act is intended to apply to cases precisely like this one, where Nazi-looted art is at issue."
